FINDING AND ORDER

I. SUMMARY

{¶ 1} The Commission finds that Certificate No. 12-SPV-PA-GATS-0387 should be revoked, and this case should be dismissed and closed of record.

II. DISCUSSION

{¶ 2} On December 19, 2011, SRECTrade Inc., on behalf of Gilbert Solar (Applicant), filed an application for certification of a renewable energy resource facility (Facility) located at 104 Summit Road, Malvern, PA 19355. According to the application, the Facility is a solar photovoltaic system with a projected gross annual generation of 5.607 MWH.

{¶ 3} Ohio Adm.Code 4901:1-40-04(D)(2) provides for automatic approval of an application for certification as an eligible Ohio renewable energy resource generating facility, unless suspended by the Commission.

{¶ 4} The Commission approved the application by Finding and Order issued February 17, 2012. The Facility was issued Certificate No. 12-SPV-PA-GATS-0387.

{¶ 5} On September 24, 2020, SRECTrade Inc., on behalf of Applicant, filed a letter indicating that the Facility is no longer in operation. SRECTrade Inc., on behalf of Applicant, requested the Commission revoke Certificate No. 12-SPV-PA-GATS-0387.

{¶ 6} The Commission finds Applicant's request to revoke Certificate No. 12-SPV-PA-GATS-0387 is reasonable and should be granted.

III. ORDER

{¶ 7} It is, therefore,

{¶ 8} ORDERED, That Applicant's request to revoke the Certificate No. 12-SPV-PAGATS-0387 be granted. It is, further,

{¶ 9} ORDERED, That Case No. 11-5971-EL-REN be dismissed. It is, further,

{¶ 10} ORDERED, That a copy of this Finding and Order be served upon all parties of record.
