#### MEMORANDUM IN SUPPORT

#### I. INTRODUCTION

On October 7, 2020, Powell Creek Solar, LLC (Applicant) filed a motion for waiver of several provisions of the Ohio Administrative Code (Ohio Adm.Code) in its case before the Ohio Power Siting Board (Board). Applicant is seeking a waiver of Ohio Adm.Code 4906-4-08(D)(2) – (4), regarding study areas for the project's impact on landmarks, recreational areas, scenic areas, and overall visual impacts outside of five miles of the project; and Ohio Adm.Code 4906-4-08(A)(1)(c), which requires the submission of manufacturers' safety manuals or similar documents and any manufacturer recommended setbacks.

As explained below, the Staff of the Ohio Power Siting Board (Staff) believes that good cause exists for the Board to deny Applicant's requested waiver of Ohio Adm.Code 4906-4-08(A)(1)(c), but asserts no objection to a waiver of the requirements of Ohio Adm.Code 4906-4-08(D)(2)-(4).

# II. PROVIDING MANUFACTURER'S SAFETY MANUAL AND RECOMMENDED SETBACKS

Staff objects to the request for waiver of Ohio Adm.Code 4906-4-08(A)(1)(c). Applicant requests a waiver of its responsibility to file the manufacturer's safety manuals and setback requirements as part of its initial application. Applicant states that it will not select the exact solar panels until the final engineering of the Project is complete. As

provided in its application Exhibit A, the Applicant only provided manufacturing equipment specifications for the Jinko brand of solar panels.

Staff objects to this waiver request. In performing the investigation necessary to analyze this application, Staff must understand the requested layout of the facility and also consider how far away the generation facilities will be from other neighboring properties. Staff also asserts that without having the recommended setback requirements and manuals from the manufacturer, there may be other issues, e.g. safety warnings, that may be important factors recommended by the manufacturer to consider in the review of the project application and should be a part of the application.

Therefore, Staff asks that the Applicant not be permitted to omit requirements of the Ohio Adm.Code 4906-4-08(A)(1)(c).

### III. CONCLUSION

For the foregoing reasons, Staff asks the Board to deny Applicant's request for a waiver of Ohio Adm.Code 4906-4-08(A)(1)(c). Staff again asserts that it has no objection to Applicant's request for a waiver of Ohio Adm.Code 4906-4-08(D)(2)-(4). Staff reserves the right to investigate and contest any other issues presented in the application as necessary.
