**MEMORANDUM IN SUPPORT**

nTherm is authorized to provide retail generation, power marketer, aggregation, and power broker services in this state pursuant to Certificate No. 18-1330E in Case No. 18-1368-EL-CRS. nTherm is also authorized to provide competitive natural gas, aggregation, broker, and marketer services in this state pursuant to Certificate No. 16-534(G) in Case No. 16-1494-GA-CRS.

Pursuant to the Commission’s entries issued on January 29, 2020, April 22, 2020, and August 26, 2020 in this docket, nTherm filed annual reports for calendar year 2019, for both of its certificates, on August 31, 2020. However, due to an inadvertent error the revenue amounts were incorrectly listed in the Annual Reports. nTherm stands ready to file amended Annual Reports with the appropriate revenue amounts.

Good cause exists to allow nTherm to amend its Annual Reports. The amendments will ensure the revenue information provided to the Commission is accurate. nTherm has taken steps to ensure this mistake does not occur again. Further, as the revised Annual Reports are already prepared, nTherm will be able to file both Amended Annual Reports immediately upon receiving permission from the Commission to submit the filing. Upon approval of this Motion, nTherm will work with Staff to submit Amended Annual Reports, for both of its certificates, electronically via the Commission’s web-based filing system for submitting annual reports.

WHEREFORE, nTherm respectfully requests that this Motion for Leave to Amend Annual Reports be granted, and that nTherm be granted permission to file its Revised Annual Reports, for both of its certificates, as soon as possible.
