



MEMORANDUM IN SUPPORT OF MOTION

Vesta Solutions, Inc. ("Vesta") is authorized to provide Competitive Emergency Telecommunications Services in the State of Ohio and is a regulated public utility.

Pursuant to the Commission's entries in this docket, Vesta filed its Annual Report for calendar year 2019 on May 20, 2020. After the filing of the Annual Report, Vesta discovered an inadvertent error in the reported information. Revenue reported was determined to be from services which was not representative of intrastate gross receipts; regulated revenue earned on regulated services within the state, excluding earnings or receipts from sales to other public utilities for resale. Vesta has not yet begun providing regulated services in Ohio, thus revenue should have been reported as zero. Consequently, Vesta requests leave to amend its Annual Report.

Upon the Commission's grant of this motion, Vesta will make arrangements with the Commission's Fiscal Office to submit the amended Annual Report electronically through the Commission's web-based filing system known as the PUCO Community. With zero revenue, Vesta would anticipate that the assessment currently due from Vesta would be adjusted accordingly.

WHEREFORE, Vesta respectfully requests that this motion for leave to amend its 2019 Annual Report be granted.


