MEMORANDUM IN SUPPORT

Volunteer Energy Services, Inc. (“VESI”) is authorized to provide electric aggregation and power broker services in this state pursuant to Certificate No. 15-950-E(3), which was issued by the Commission on March 22, 2019 in Case No. 15-0375-EL-CRS.

VESI filed its Annual Report for Fiscal Assessment (the Annual Report”) for calendar year 2019 on April 17, 2020. However, Staff noticed a discrepancy in sale volumes contained in the Annual Report and the volumes contained in the RPS Compliance Report filed on April 20, 2020 in Case No. 20-0904-EL-ACP and reported the inconsistency to VESI. VESI has confirmed that the volumes contained in the RPS Compliance Report are the correct volumes. Accordingly, by this application, VESI requests leave to amend its 2019 Annual Report to show the correct volumes (revenue was correctly stated in the original Annual Report).

Upon approval of this Motion, VESI will submit an amended Annual Report electronically via the Commission’s web-based filing system for submitting annual reports.

WHEREFORE, VESI respectfully requests that this Motion for Leave to Amend Its Annual Report be granted, and that VESI be granted permission to file its Revised Annual Report.
