MOTION FOR EXTENSION

Pursuant to Ohio Administrative Code Rule 4901:1-27-09(B), LE Energy LLC, dba Utility Gas and Power (“LE”) seeks an extension of Certificate No. 16-561G (2), which was issued in this proceeding with an expiration date of December 2, 2020. Due to an inadvertent calendaring error, LE missed the deadline and was not able to file its renewal application thirty days prior to its expiration. LE filed its Renewal Application contemporaneous with this Motion on December 1, 2020, which is one calendar day prior to the December 2, 2020 expiration date. In support of the application, LE respectfully requests that Certificate No. 16-561G (2) be automatically extended from December 2, 2020 until January 2, 2021 or until the date that the renewal certificate is issued.
