Reliant Energy Northeast, LLC (“Reliant”) is authorized to provide competitive retail electric and natural gas services in Ohio, and holds Certificate Nos. 11-401E(5) and 17-591G(2), which were issued in Case Nos. 11-5191-EL-CRS and 17-621-GA-CRS respectively.

Pursuant to the Commission’s directive in its January 29, 2020 Entry in this docket, Reliant submitted its Annual Report for Fiscal Assessment for calendar year 2019 on April 24, 2020. It was discovered recently, following a Staff inquiry about the sales volumes contained in Reliant’s RPS Compliance Report filed on April 15, 2020, in Case No. 20-809-EL-ACP, that the sales volumes contained its 2019 Annual Report inadvertently omitted part of one month’s sales information. Through this motion, Reliant requests leave to amend its 2019 Annual report to report the correct volumes and revenues.

Upon approval of this motion, Reliant will proceed to amend and resubmit the 2019 Annual Report through the Commission’s PUCO Community.

WHEREFORE, Reliant respectfully requests that the Commission grant its motion and allow it to amend its Annual Report for Fiscal Assessment for calendar year 2019.
