



Notice of Public Information Meeting for Proposed Major Utility Facility

Yellow Wood Solar Energy LLC, a wholly-owned subsidiary of Invenergy, scheduled a virtual public informational meeting for December 17, 2020. The facility will be sited on approximately 2,700 acres and have a maximum total generating capacity of up to 300 megawatts. The purpose of the facility is to generate electricity to inject into the local transmission grid. Construction is anticipated to begin as early as the second quarter of 2021, resulting in commercial operations in the fourth quarter of 2023. A map showing the general outline of the project area is below.

On December 17, 2020, from 6 p.m. to 8 p.m., Yellow Wood Solar will host a public information meeting that will be virtual and will consist of a presentation about the proposed facility and approval process, as well as a live web/phone question and answer (Q&A) session on the project. This live Q&A session is being held in accordance with Rule 4906-3-03 of the Ohio Administrative Code, and the Ohio Power Siting Board's entry issued on November 18, 2020, in Case No. 20-1680-EL-BGN . To access the live web/phone public information meeting and Q&A session on December 17, 2020, attendees can view the presentation online at the following link: www.InvenergyPublicMeetings.com. No advance registration is necessary. 

Yellow Wood Solar Energy LLC anticipates filing its application with the Ohio Power Siting Board (OPSB) within 90 days of the live web/phone Q&A session. OPSB's case number for the project is 20-1680-EL-BGN and the filings made with the OPSB in the case can be viewed at <http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=20-1680&x=0&y=0>.

Upon the receipt of the application, OPSB will review the application to determine if it is complete so OPSB staff can begin its investigation. Should OPSB find the application complete, OPSB will set a date for public hearing, not less than 60 nor more than 90 days after such finding. The public hearing consists of two parts: a public hearing where OPSB will accept written or oral testimony and an adjudicatory hearing. 15 days prior to the public hearing, OPSB's staff will submit a written report on the project.

OPSB accepts written comments on the project from interested persons at any time, as well as written or oral testimony from any person at the public hearing. Petitions to intervene in the adjudicatory hearing will be accepted by OPSB in accordance with a deadline set by OPSB.
