RESOLUTION ---- AUTHORIZING THE MUSKINGUM COUNTY COMMISSIONERS TO ACT AS THE PURCHASING AGENT AND GOVERNMENTAL AGGREGATOR FOR ELECTRIC POWER FOR FALLS TOWNSHIP.

The Trustees of Falls Township, Muskingum County, Ohio, met in regular session on the 21st. day of December 2020, at the Township Hall, 3105 Dillon Falls Rd, Zanesville, Oh 43701 with the following members present:

Charles H Archer, Jr. Steve Dillon John W Huey

Trustee Steve Dillon moved the adoption of the following resolution:

Whereas, on November 3, 2020, the residents of Falls Township voted in favor of electric aggregation to improve purchasing leverage and offer reduced electrical generation rates to residential and small business consumers, and,

Whereas, the Muskingum County Commissioners have offered their services to act on behalf of Falls Township in Muskingum County as the governmental aggregator, and,

Whereas, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of electrical aggregation,

THEREFORE, Be It Resolved,

Section 1: The Trustees of Falls Township of Muskingum County hereby authorizes the Muskingum County Commissioners to act as the governmental agent for purchasing and aggregation of electric power for the residents of Falls Township.

Section 2: This resolution shall be copied to the Muskingum County Commissioners, 401 Main Street, Zanesville, Oh 43701.

Section 3: It is found and determined that all formal actions of the Falls Township Trustees concerning and relating to the adoption of this resolution were so adopted in an open meeting of the Trustees, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.

Trustee Charles H Archer, Jr. seconded the above resolution and the vote upon its adoption resulted as follows:




