Combined, these consumers represent over 4,000,000,000 kWh per year of electricity consumption. The firm has provided services to



customers in over 15 different utility territories that fall within the MISO, PJM, ERCOT, and WPP regional control areas. 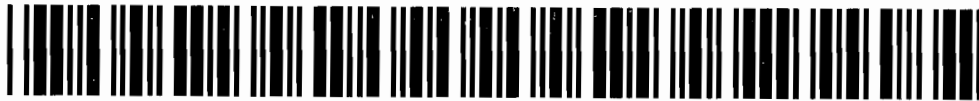

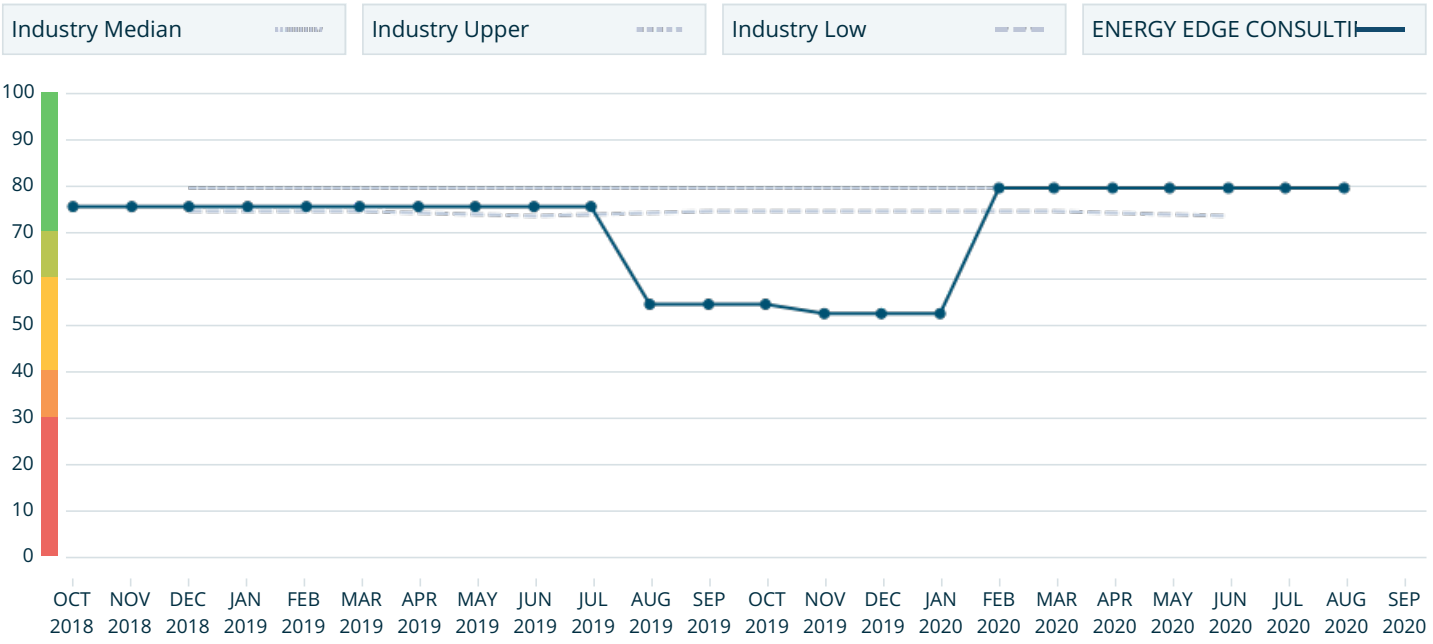

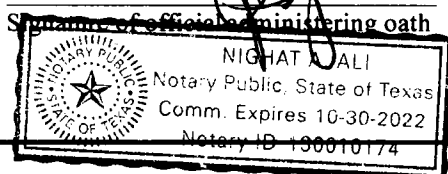
