**SUBJECT:** Ohio Power Company - Protest Rate Case

I am leaving a long but important comment. I would think that everyone knows all ready but just in case they don't. This needs to be said for the safety of our health etc.

Across the world electric utilities wants people to use under 1000 kilowatts per month. AEP is doing the same. This has to do with the green new deal dealing with natural energy use. Trying to get people to use less. They will continue to charge even more over time for those who use a little more over 1000 kilowatts. Natural energy is being used in California to some degree and it is failing to supply enough power to the public. Bu 2030 California plans to have around 66% of natural energy supplying the power. Even though they are miserably failing with major blackouts with the amount of natural energy resources they are using now. Can you imagine the pure chaos that would happen here in Ohio especially during the winter season. The new green deal is part of the great reset 2030

known as technocracy. Solar farms effect the local climate. It warms the surrounding air and cause more rain and more vegetation. In humid areas possibly more humidity which can cause heath issues and property damage.

There are several electric plans that are shown on the Choose Energy website and I will mention a couple that concerns me.

The prepaid plan: Prepaid plans allow one to pay for a certain amount of electricity before use it. Once you've hit the set amount you've paid for, the lights disconnect. They'll be reconnected usually within a few hours once you add money to your account.

The Fixed plans: Tiered rates happen when a provider designates certain usage buckets. For example: One might pay a flat fee of \$75.00 for up to 1000 kwh. and another \$75.00 for the next 1000 kwh. This means that one would pay an extra \$75.00 whether one used 1001 kwh or 1999 kwh. These buckets are set when you sign up and stay the same for the duration of your contract period, making it a fixed plan structure. No more paying for what you actually use. With AEP increasing everything over 1000 kwh if they go to this kind of plan people would be paying outlandish bills for energy they never used.

I do fear that AEP will be going towards this direction. I fear power would be turned off if goes over 1000 kilowatts the smart meters already can turn power off from a few miles away from some ones home. What is AEP plans for people who need power who are on medical equipment or those on fixed income? Several people have died in Ohio when their power went off. I remember about 10 years ago an elderly gentleman who was 90 years old lived by himself and was 800.00 behind on his bill. He was always cold and had his heat over 80 degrees. He was told that his power would be turned off if he kept his heat over 80 degrees. What elderly person doesn't at times go over that temp. Have you ever gone into a senior citizen apartment complex.

In the halls are over 80 degrees. Some elderly with poor blood circulation need 80 degrees to keep warm. They sent out an utility worker to come out and put a breaker on his electric box to turn his power off if he kept putting his heat over 80 degrees. Neighbors were never informed of what was happening in order to keep an eye out. If he had any kids where they even told what the utility company's plan was. His power was shut off during the time we had freezing weather that registered -25 degrees below zero that was occurring every night for 2 weeks. His neighbors saw ice forming inside his windows one morning and they found him deceased on the couch with blankets around him. What does AEP plan to do for these people! We all can become destitute in the same way when everything keeps going up as they are now.

Their increase for 36.2 million of additional revenue per month or yearly I

strongly feel is for their upgrade for 5G endeavors. 5G is dangerous for people's health. There is scientific proof of it despite the big tech companies denials and say it is safe. There has never been tests to prove that it is safe. WI-F- and electromagnetic microwaves were developed as secretive weapons of war in the 1950. Silent weapons for quiet wars' as their promoters described them, in the course of military defense programs secretively rolled-out during the cold war period of the stand-off between Russia and the USA. US Army in crowd dispersal guns called Active Denial systems. Today research has also shown that the same frequencies used by the Department of Defense in crowd control weapons actually form the foundation of the 5G network. There is evidence showing strong links to cancer, brain abnormalities, and a number of other health problems related to these new technologies and have cautioned against 5G technology.
