This letter serves as the Pre-Application Notification Letter to the Ohio Power Siting Board ("Board") of Union Ridge Solar, LLC's ("Applicant" or "Union Ridge") application for its proposed solar-powered electric facility.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-3-03(A), Applicant provides the following information:

- **Project Description.** Union Ridge is proposing to develop, construct, and operate a 108 megawatt ("MW") solar-powered electric facility in Harrison Township, Licking County, Ohio. The Applicant expects to file its application to the Board in March 2021. Construction of the Project is expected to begin in late 2021, with commercial operations in 2022.
- **Pre-Application Public Informational Meetings.** In accordance with Union Ridge's December 3, 2020 motion for limited waiver and the Board's December 16, 2020 entry, Union Ridge will be holding web-based and teleconference Public Information Meetings. The Applicant plans to hold an approximately two-hour web-based Public Information Meeting on February 25, 2021 beginning at 6:00 p.m. The Applicant will also hold an approximately two-hour-long teleconference session on February 25, 2021 at 8:00 p.m.
