Thank you for contacting the Public Utilities Commission of Ohio (PUCO) regarding Ohio Power Company (AEP) and its application to increase its rates.

The PUCO is responsible for ensuring that utilities across the state provide safe and reliable services. Great care is taken to review the utilities' financial records to make certain that the rates set do not result in the over-collection of revenue.

On June 8, 2020, AEP filed an application to increase its annual revenue in the amount of approximately \$42 million, or 3.5% of their average

annual total revenue. The PUCO staff is in the process of investigating the facts and issues in the company's application, preparing a staff report, and scheduling a local public hearing.

The company's application and all related documents are available at [www.PUCO.ohio.gov](http://www.PUCO.ohio.gov), case no. 20-0585-EL-AIR. Click on the link to "Docketing information System" (DIS).
