Pursuant to the Finding and Order issued on November 7, 2018 in Case No. 18-0376-GA-RDR and the Finding and Order issued on November 1, 2017 in Case No. 17-0594-GA-ALT, Suburban hereby files its updated Energy Efficiency Program Rider (Rider EEP) tariff sheet, effective immediately, to set the Rider EEP rate to zero, pending the outcome of its annual reconciliation application filed on February 1, 2021 in Case No. 21-0105-GA-RDR. Pursuant to the Public Utilities Commission of Ohio's orders issued in Case Nos. 18-0376-GA-RDR and 17-0594-GA-ALT, Suburban was authorized to collect Rider EEP for twenty-four months. As explained in Suburban's February 1, 2021 annual reconciliation application, the authorized twenty-four-month collection period has expired. Accordingly, to avoid further over-collection pending the outcome of the reconciliation case, Suburban is updating its tariff sheet to reflect that it will no longer collect Rider EEP from customers, thereby setting the Rider EEP rate to zero, effective immediately. A copy of this filing has also been filed in Suburban's Tariff Docket, Case No. 89-8027-GA-TRF.
