The monthly rate for residential Flat Rate Service will increase by \$2 on 3/1/2021. If you subscribe to one of our packages you may not be impacted by this entire increase. For more information, please visit us at att.com or call 800.288.2020.

Note: A residential customer's local exchange service consists of <u>three tariffed components</u>: a network access line, a central office termination and usage. However, these <u>three tariffed components</u> are displayed as <u>two charges</u> on the customer's bill, a Line Charge and a Usage Charge. For example, for flat rate local service, using rates in effect prior to 3/1/2021; the rate is calculated and shown on the bill as follows:

Network Access Line	\$18.40 —	Displayed as \$20.70 "Line Charge" on the bill.
Central Office Termination	\$2.30	
Flat Rate Usage	\$7.55	Displayed as "Unlimited Residence Service" charge on the bill.
Total	\$28.25	

Customer bills display a Line Charge of \$20.70, which is a combination of the network access line rate (\$18.40) and the central office termination rate (\$2.30), as well as an Unlimited Residence Service (flat rate usage) rate of \$7.55. As a result of the 3/1/2021 rate increase, the tariffed rate for a flat rate residential network access line will increase by \$2.00, going from \$16.40 to \$18.40. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$18.70 to \$20.70. So, for flat rate local service, using rates in effect subsequent to 3/1/2021, the rate will be calculated and shown on the bill as follows:

Customers affected by the rate increase will see their bill for flat rate local service increase from \$28.25 (\$20.70 + \$7.55) to \$30.25 (\$22.70 + \$7.55).
