## Commissioners,

Staff respectfully requests an expansion of the scope of the audit ordered in Case No. 20-1629-EL-RDR.

Immediately following its review of the 10Q filed by the First Energy Corporation on February 18, 2021, Staff filed a data request with Cleveland Illuminating Company, Ohio Edison and Toledo Edison (collectively referred to hereafter as "the Utilities") for additional records related to a disclosure of "certain transactions.... that were either improperly classified, misallocated...or lacked supporting documentation." See page 28 of the attached 10Q. The Utilities responded to this data request on February 25, 2021.

Through our preliminary review of documents provided in response to this request, staff believes it is appropriate for the assigned independent auditor in Case No. 20-1629-EL-RDR, Blue Ridge Consulting, Inc., to review these transactions to determine whether funds collected from ratepayers were used to pay these vendors and if so, whether or not the funds associated with those payments should be returned to ratepayers as part of the Commission's review of the Utilities' delivery capital recovery rider.

In the event the independent auditor and/or staff find that ratepayers would be entitled to a refund in an alternative proceeding of the Utilities, the independent auditor and/or staff shall file a supplemental report that references and incorporates the relevant findings of the auditor and staff in the appropriate docket.

Staff notes that additional time and funds may be necessary to perform the expanded audit described above.
