**NOTICE OF INTERVENTION OF THE BOARD OF TRUSTEES

3. That it intends to intervene in the proceedings on the grounds that it has an extensive interest in the proceedings as the elected representatives of the citizens of Paint Township, Ross County, Ohio; that said township's interest is not and cannot be represented by another party, existing or otherwise, that its contribution of presenting to the Board the costs and benefits of the project to the citizens of Paint Township is essential to a just and expeditious

resolution of the issues involved in the proceeding and that it would not unduly delay the proceeding or unjustly prejudice an existing party.
