MEMORANDUM IN SUPPORT

Cleveland-Cliffs Steel LLC, formerly known as ArcelorMittal USA LLC, has a CRES certificate to provide marketing services that was granted to the company in Case No. 11-2691-EL-CRS. During 2019, the company was doing business as ArcelorMittal USA LLC; however, as previously noticed to the Commission in its certificate docket, Case No. 11-2691-EL-CRS, on December 9, 2020 Cleveland-Cliffs Inc. acquired a 100 percent upstream ownership interest in ArcelorMittal USA LLC. The company's new name of Cleveland-Cliffs Steel LLC has been registered with the Ohio Secretary of State.

It has come to the attention of Cleveland-Cliffs Steel LLC that its 2020 annual report for calendar year 2019 sales and revenue had an error regarding reported kilowatt hours ("kWh") sales. The annual report that was filed listed kWh sales as 635,613.0000 when the correct value should have been 635,652,494 kWh. Upon approval of this Motion, the company will file with the Commission an updated annual report with the corrected kWh sales value.
