## **MEMORANDUM IN SUPPORT**

In accordance with O.A.C. 4901:1-36-03(A), AES Ohio proposed and was granted authority to file its annual update of the Company's Transmission Cost Recovery Rider – Non-Bypassable ("TCRR-N") by March 15 each year. AES Ohio prepared such a filing and attempted to timely file the Application on March 15. Unfortunately, AES Ohio's internal communications and document management system, Microsoft Teams, suffered from worldwide technical difficulties that the Company understands were not resolved until after close of business on March 15th. As a result, AES Ohio was unable to access the documents necessary to complete the filing by 5:30 PM.

Granting this Motion for Leave for a single day extension will not prejudice any parties, as no parties have intervened in the case and nearly all parties have historically refrained from intervening in TCRR-N update filings.<sup>2</sup> Nor will it prolong this proceeding because this is a routine filing to update the TCRR-N that has existed in its current form since January 1, 2014. The Commission's rules permit it to grant leave to file pleadings out of time when doing so will cause no harm to the parties and has granted similar leaves due to technical difficulties.<sup>3</sup>
