Duke Energy Ohio recently requested approval by the Ohio Power Siting Board for this Bandanna Drive project. Due to a minor change in the proposed alignment of the pipeline, the Company is now filing a new application.

Duke Energy Ohio proposes the replacement of approximately 2,000 feet of existing pipeline. The proposed pipe will be sized such that calculated hoop stress is below 20% SMYS with a pressure of 170 pounds per square inch (psi) operating pressure. The pipe will be 24" outside diameter x 0.375" wall thickness, American Petroleum Institute (API) 5L Grade X65 pipe material, and American National Standards Institute (ANSI) Class 300 fittings will be used. Design requirements of the new 24" pipeline replacement sections include a maximum allowable operating pressure (MAOP) of 500 pounds per square inch gauge (psig) and operating pressure of 170 psig.

Installing the new 24" diameter pipe will allow the system to operate below 20% SMYS, be changed in PHMSA designation from transmission to distribution system, and continue safe/efficient delivery to Duke Energy Ohio's industrial, commercial, and residential customers.
