**JOINT MOTION FOR EXTENSION OF TIME**

By Entry dated March 2, 2021, the Commission directed The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO) to file, by March 29, 2021, a statement informing the Commission whether the issues raised in the comments have been resolved. The Commission also directed Staff and DEO to file testimony by March 31, 2021, if no resolution is reached.

Staff filed comments on March 23, 2021. DEO and Staff are currently working to resolve the issues raised in Staff's comments.

DEO now requests an extension of three days of the deadline to file a statement on whether issues raised in the comments have been resolved and an extension of one day to file testimony, if DEO and Staff cannot resolve these issues. Either filing would be due by April 1, 2021. An additional three days will enable DEO and Staff to continue their dialogue regarding resolution of the issues. Staff does not object to the requested extension.

Accordingly, DEO respectfully requests an extension of three days to file the statement and one day to file testimony, if no resolution is reached, or until April 1, 2021.
