MEMORANDUM IN SUPPORT

In support of this Motion for Leave to File a Notice of Appearance, IEU-Ohio states that it timely intervened in this proceeding on July 2, 2019. In the intervening time, counsel for IEU-Ohio has changed, including an attorney that is no longer representing IEU-Ohio. As part of this filing, IEU-Ohio has provided notice of the withdrawal of that counsel for IEU-Ohio.
