On March 18, 2021, Hecate Energy Highland 4, LLC ("Hecate Energy) was issued a certificate of environmental compatibility and public need ("Certificate") by the Ohio Power Siting Board ("Board") to construct a 65 MW solar-powered electric generating facility in Clay and Whiteoak Townships, Highland County, Ohio. The Certificate was issued subject to twenty three (23) conditions.

At this time, Hecate Energy is confirming that the pre-construction conference relative to its second phase of construction activity contemplated by Condition #2 was held on April 9, 2021. We have also attached the detailed engineering plans submitted to Board Staff prior to the pre-construction conference for this latest phase consistent with Condition #8. Finally, Hecate Energy is confirming it will begin construction of this second phase of construction on April 14, 2021 consistent with Condition #5.

With this filing, Hecate Energy will have complied with Conditions #2, #5 and #8 of the Certificate. If you have questions or need additional information, please do not hesitate to call.







