**OHIO EDISON COMPANY’S REPLY MEMORANDUM TO OHIO EDISON
COMPANY’S MOTION TO STAY**

On March 31, 2021, Ohio Edison Company (“Ohio Edison” or the “Company”) filed its Motion to Stay and Memorandum in Support. On April 9, 2021, Complainant filed correspondence disagreeing with Ohio Edison’s Motion to Stay. As discussed in the Memorandum in Support, Ohio Edison’s request for a stay of the proceedings involved in this matter was primarily due to an ongoing investigation within the Company’s claims department involving Complainant and the same issues presented in Complainant’s Complaint. A temporary stay was in the best interest of efficiency and economy, as Complainant’s allegations could have potentially been resolved through the claims process. With this Reply Memorandum, Ohio Edison advises the Commission that Ohio Edison’s claims department has concluded its investigation of the issues Complainant directly submitted to the Company.

Following thorough investigation, Ohio Edison’s claims department denied Complainant’s claim as of April 12, 2021. Ohio Edison is prepared to proceed with this case at this time and will be filing an Answer to Complainant’s Complaint contemporaneously with this Reply.
