EXHIBIT A: DESCRIPTION OF SERVICES

Exhibit A-1 Description of Proposed Services

The Applicant seeks authority to provide telecommunications services throughout the State of Ohio on a facilities-based and resale basis. The Applicant intends to provide special access and private line services, including Ethernet and Wavelength services, lit and dark fiber to wholesale, education, healthcare, government and enterprise customers. As detailed elsewhere in this application, the Applicant will provide competitive telecommunication services but does not seek authority at this time to provide basic local exchange services.

Exhibit A-3 Statement about the Provision of CTS Services

As further described in this Application, Applicant will provide competitive telecommunications services. Applicant does not seek to provide basic local exchange services (BLES), nor competitive emergency telecommunications carrier services. Applicant will not provide retail services. Applicant also intends to provide telecommunication and broadband infrastructure services to other educational, healthcare, government, banking, telecommunications and business customers throughout the state. Applicant will primarily provide services using its own facilities and facilities leased from other carriers, but also seeks authority to provide services on a resold basis.

Exhibit A-6 Class of Customers to be Served

Applicant will primarily provide services to wholesale (e.g., other carriers), education, healthcare, government and enterprise customers. Applicant will not provide services to residential customers. Applicant proposes to provide customized service solutions to educational, healthcare, government, banking, telecommunications and business customers in Ohio. Applicant's typical customers are sophisticated users of telecommunication services and the services they purchase from Applicant are often highly customized to the individual customer. Applicant's customers typically purchase services through a competitive bidding process and negotiate rates on an individual case basis.
