On April 30, 2021 pursuant to Ohio Administrative Code 4901-1-25(A), the Environmental Law and Policy Center (ELPC) and Ohio Environmental Council (OEC), respectfully moved the Public Utilities Commission of Ohio (PUCO) to issue a subpoena to compel the attendance of Jon F. Williams to give testimony at the hearing scheduled to begin May 12, 2021.
