FINDING AND ORDER

I. SUMMARY

{¶ 1} The Commission finds that Certificate No. 11-SPV-PA-GATS-1777 should be revoked, and this case should be dismissed and closed of record.

II. DISCUSSION

{¶ 2} On May 19, 2011, Theodore Hartley (Applicant) filed an application for certification of a renewable energy resource facility (Facility) located at 583 Gray Hill Road New Columbia, Pennsylvania 17856. According to the application, the Facility is a solar photovoltaic system with a projected gross annual generation of 1,311 kilowatt hours.

{¶ 3} Ohio Adm.Code 4901:1-40-04(D)(2) provides for automatic approval of an application for certification as an eligible Ohio renewable energy resource generating facility, unless suspended by the Commission.

{¶ 4} The application was automatically approved, and the Facility was issued Certificate No. 11-SPV-PA-GATS-1777 on July 20, 2011.

{¶ 5} On February 23, 2021, Applicant filed a letter requesting that the Commission revoke Certificate No. 11-SPV-PA-GATS-1777, as Applicant no longer wants an Ohio certification.

{¶ 6} The Commission finds Applicant's request to revoke Certificate No. 11-SPV-PA-GATS-1777 is reasonable and should be granted.

III. ORDER

{¶ 7} It is, therefore,

{¶ 8} ORDERED, That Applicant's request to revoke the Certificate No. 11-SPV-PA-GATS-1777 be granted. It is, further,

{¶ 9} ORDERED, That Case No. 11-2815-EL-REN be dismissed and closed of record. It is, further,

{¶ 10} ORDERED, That a copy of this Finding and Order be served upon all parties of record.
