Dear Ms. Troupe:

Staff of the PUCO Transportation Division makes the following statements:

- 1. On 01/21/2021, a vehicle operated by Nesco Transportation Inc and driven by Ali YMohammed, was inspected within the state of Ohio.
- 2. On 01/25/2021, as a result of the inspection Ali Y. Mohammed. (Applicant) was served with a Notice of Intent to Assess a Forfeiture (NIF) for violation(s) of the Commission's rules. The notice provided approximately thirty (30) days for the applicant to respond to the notice requesting and administrative hearing or pay the forfeiture due. The notice advised the applicant that failure to respond to the notice would result in admission of theviolations as fact and potential suspension of applicant's CDL. The Notice also advised that payment of the forfeiture would act as an admission of the violations.
- 3. Applicant did not pay the forfeiture amount or otherwise respond to the NIF.
- 4. On 02/24/2021, a Second NIF was sent to Applicant. The notice provided approximatelythirty (30) days for the applicant to respond to the notice requesting and administrative hearing or pay the forfeiture due. The notice advised the applicant that failure to respond to the notice would result in admission of the violations as fact and potential suspension of applicant's CDL. The Notice also advised that payment of the forfeiture would act as an admission of the violations.

- 5. On 03/23/2021, payment was received from the applicant for the full forfeiture amount of \$500 and the invoice was closed.
- 6. On 04/26/2021, Applicant called and spoke with the compliance officer assigned to the case twice. The Compliance Officer explained that the case is closed due to payment. The Compliance Officer emailed instructions on filing a motion to reopen the case to nesco.trans@icloud.com.
- 7. On 04/29/2021, The applicant filed a letter requesting that the Commission reopen his case. The Docketing Division, as is its custom, opened a case and docketed this request.

Staff recommends denial of the request to reopen this case because it is an improper attempt to argue a matter that is already closed. Applicant was provided multiple opportunities to request anadministrative hearing of his case. The Applicant was also advised on multiple occasions that payment of the forfeiture would constitute an admission of guilt and acceptance of all penalties against the applicant.
