Background

On May 10, 2021, Ohio Power Company (Company) filed proposed Generation Energy (GENE) and Generation Capacity (GENC) riders in Case No. 21-558-EL-RDR. The proposed tariffs include Standard Service Offer (SSO) generation rates, Time of Day (TOD) generation rates and Percentage of Income Payment Plan (PIPP) generation rates.

The proposed SSO and TOD rates include the results of the most recent auction held March 9, 2021, approved by the Commission on March 10, 2021, in Case No. 17-2391-EL-UNC. The proposed PIPP generation rate reflects the results of the PIPP auction held May 4, 2021, and approved by the Commission on May 5, 2021, in Case No. 16-1031-EL-UNC.

The Company requests that the proposed tariffs become effective on June 1, 2021.

Staff Review and Recommendations

Staff has reviewed the proposed tariffs filed on May 10, 2021, and finds that the tariffs appear to be in compliance with Commission Orders and accurately reflect the appropriate auction results, including the most recent auction results approved by the Commission on March 9, 2021 and May 4, 2021.

Conclusion

The Staff recommends that the proposed tariffs filed on May 10, 2021, be approved and become effective June 1, 2021.
