**RIDER GCRR**  
**GAS COST RECOVERY RATE**

The Gas Cost Recovery Rate (GCRR) shall be determined in accordance with Chapter 4901:1-14 of the Ohio Administrative Code, which is substantially cited in its entirety on Sheet No. 70 of this Tariff, P.U.C.O. Gas No. 18.

The GCRR to be charged during the revenue month of June 2021 is \$0.5565 per 100 cubic feet.

**RIDER CCCR**

**CONTRACT COMMITMENT COST RECOVERY RIDER**

**APPLICABILITY**

Applicable to all firm sales and firm transportation customers.

**CONTRACT COMMITMENT COST RECOVERY RIDER**

All firm customers served pursuant to Rates RS, Rate RS – Low Income, Rate GS – Small, Rate GS – Large, Rate RFT, Rate RFT – Low Income, Rate FT – Small and Rate FT – Large shall be assessed a surcharge to enable the Company to fully recover all costs of upstream pipeline contract commitments, propane costs, and costs for Duke Energy Ohio to transport gas across Duke Energy Kentucky's transmission lines which were incurred to supply gas to firm sales service customers who have elected to switch to gas transportation service.

The rate shall be in effect during the months of June 2021 through August 2021, and shall be updated quarterly, concurrent with the Company's Gas Cost Recovery filings, to reflect the amounts allocated to firm transportation customers for incremental cost of propane used for maintaining system pressure, any pipeline overrun or OFO penalty charges incurred due to system constraints, and the cost of unneeded capacity, net of any costs that the Company is able to recover via its mitigation efforts, including, but not limited to, capacity release transactions. The charge for all CCF delivered for the respective gas schedules is as follows:
