## **ENTRY**

## Entered in the Journal on May 19, 2021

- $\{\P 1\}$  6011 Greenwich Windpark, LLC (Greenwich) is a person as defined in R.C. 4906.01.
- {¶ 2} R.C. 4906.04 provides that no person shall commence to construct a major utility facility in the state without first having obtained a certificate for the facility from the Ohio Power Siting Board (Board).
- {¶ 3} On August 25, 2014, the Board adopted a Joint Stipulation and Recommendation authorizing Greenwich to build a 60 megawatt major utility facility with up to 25 wind turbines on 4,650 acres of leased land in Greenwich Township, Huron County, Ohio. *In re 6011 Greenwich Windpark, LLC*, Case No. 13-990-EL-BGN, Opinion, Order, and Certificate (Aug. 25, 2014) (*Greenwich Certificate Case*). Further, the Board's Order specifically provided that "the certificate shall become invalid if Applicant has not commenced a continuous course of construction of the proposed facility within five years of the date of journalization of the certificate." *Greenwich Certificate Case* at 26. Accordingly, Greenwich's certificate to commence a continuous course of the construction of the facility would expire August 25, 2019, unless otherwise ordered by the Board.

{¶ 4} On August 22, 2019, Greenwich filed its Safety Plan, Complaint Resolution Plan, and a notice that construction had commenced on-site.

{¶ 5} On August 26, 2019, Greenwich Neighbors United (GNU) filed a motion

requesting that the Board determine whether or not Greenwich's certificate is invalid.

{¶ 6} On September 10, 2019, Greenwich filed a memorandum contra GNU's

motion regarding the status of its certificate.

{¶ 7} GNU filed a reply on September 17, 2019.

¶8} Greenwich has not filed in either of the aforementioned dockets any

information regarding the progress of the project since October 23, 2019. Accordingly, the

Board finds that a status conference on the state of the construction of the facility should be

scheduled. Counsel for Greenwich shall be prepared to inform the Board regarding its

progress on the facility to date and, if appropriate, to complete construction. The conference

shall be scheduled for June 3, 2021, at 10:00 a.m., via Webex. Counsel for the parties to the

proceedings will be provided access information for the status conference via email.
