CLEARVIEW SOLAR I, LLC 'S THIRD SUPPLEMENTAL RESPONSE TO THE FIRST DATA REQUEST FROM THE STAFF OF THE OHIO POWER SITING BOARD

On December 18, 2020, Clearview Solar I, LLC ("Applicant"), filed an application ("Application") with the Ohio Power Siting Board ("OPSB") proposing to construct a solar-powered electric generation facility in Champaign County, Ohio.

On February 2, 2021, the Staff of the OPSB ("OPSB Staff") provided the Applicant with OPSB Staff's First Data Request. Now comes the Applicant providing the following Third Supplemental Response to the First Data Request from the OPSB Staff regarding Question 3.

<u>Question 3</u>: Please update Figure 2 (Map of Aerial View of Project Area) to reflect the location of the 138 kV gen-tie line and provide associated shapefiles.

Response: Attachment 1 to this response is a map that shows the preliminary location of: (1) the construction area for the Project's substation ("Substation"); (2) the construction area for the interconnecting utility's substation ("Utility Substation"); and (3) the path of the 138 kilovolt ("kV") gen-tie ("Gen-tie") that will connect the two facilities and deliver the power from the Substation to the Utility Substation. The preliminary design of the Gen-tie is for a span of overhead electric line (single circuit, three phase) and associated fiber optic lines between approximately 100 and 200 feet in length. (The Gen-tie is shown on the map at approximately 200 feet.) The precise location and length of the Gen-tie will not be available until after the completion of the PJM-managed Facilities Study and associated location of the dead-end structure at the Utility Substation, final sign-off by the interconnecting utility, and completion of the final design and engineering of the Project. This preliminary design, however, provides the location of the Gen-tie with sufficient detail to assess its maximum impacts relative to the public and the environment.

The Applicant will provide the precise location of the Gen-tie, as well as all other facility components, to OPSB Staff prior to the start of construction of the Project.


