## EXHIBIT C

The Applicant, **Continental Telephone Company**, hereby modifies its intrastate switched access tariff to establish separate rate elements for intrastate Toll-Free Originating End Office Access Service. In addition, intrastate Switched End Office rates associated with Toll Free traffic will be reduced to their functionally equivalent interstate rates (unless they are already lower) and all common transport charges associated with Toll Free traffic will become subsumed into a single uniform rate (Joint Tandem Switched Transport) and capped at \$0.001. Finally, Toll Free Query Charges will be capped at \$0.004248 per query. These modifications are in response to the Federal Communications Commission's Report and Order and Further Notice of Proposed rulemaking, WC Docket No. 18-156, FCC 20-143, § 51.909 (n) (Released October 9, 2020) that requires Rate of Return Carrier's to effectuate the preceding revisions, effective July 1, 2021.

The Company views these tariff changes as administrative because they are consistent with the FCC's rules.
