Alliance Energy Services, the entity formerly owned by Allegheny Energy, and Midwest natural gas marketers Kaztex Energy Management and Blackhawk Energy Services became Constellation NewEnergy-Gas Division, LLC (CNEG). NOCO Energy Marketing, LLC was acquired in April 2006. In July 2007, CNEG acquired Cornerstone Energy. In March 2012, CEG merged with Exelon Corporation. In April 2014, CNEG acquired ETC ProLiance Energy, LLC. On August 1, 2017, Compass Gas Services, LLC merged with and into Compass Energy Services, Inc. which merged with and into Constellation Energy Services – Natural Gas, LLC which merged with and into CNEG. In December 2019, CNEG acquired a group of retail customers located in the states of Kansas and Colorado from nTherm, LLC. CNEG's ultimate indirect parent is Exelon Corporation.

Jurisdiction of Operation: Constellation NewEnergy-Gas Division, LLC (CNEG) is currently licensed by the Public Utilities Commission of Ohio to serve residential, small commercial, large commercial and industrial customers in the service territories of Columbia Gas of Ohio, Dominion East Ohio, Duke Energy Ohio, and Vectren Energy Delivery of Ohio.

CNEG utilizes load profiles for specific types of customers as modified by weather to support its gas acquisition and management efforts. In 2020, CNEG served residential, commercial and industrial customers with a volume of over 44,000,000 Mcf in Ohio.


