You are receiving this letter because we wanted to let you know about a proposed power line project in your area.

AEP Ohio representatives announced in August 2018 the Carrollton-Gable Transmission Line Rebuild Project. The project involves upgrading 29 miles of 138-kilovolt (kV) transmission line in Carroll, Harrison and Jefferson counties. The upgrades strengthen the electric transmission system by replacing existing lattice towers from the 1910s with modern steel poles. The upgrades also ensure the power line complies with the company's structural standards, improves the line's operational performance and reduces the need for frequent equipment repairs. Company officials expect construction to begin this fall and conclude summer 2024.





Jefferson County sheriff Don't do it: A 16-year-old Dillonvale youth irritated by a scam telemarketing call left a voicemail message that tripped alarms with Homeland Security, Thursday. The youth allegedly left a voicemail on what he thought was the telemarketer's phone suggesting he'd "bombed the embassy in Iran with a car full of plastic explosives and how he is joining Al Qaeda." Investigators with the Joint Terrorism Task Force Homeland Security Investigation traced the caller to a home in Mount Pleasant township, where deputies said the teen admitted trying to call the telemarketer back to "prank them." The scammers apparently had spoofed the phone number that appeared on the youth's caller ID as an individual who actually owns that number found the message


