


### Figure 08-1 Sensitive Receptors Map









### Figure 08-2 Aquifers, Water Wells, Source Water Protection Areas, and Floodplains Map


## Figure 08-4 Ecological Communities Map




### Figure 08-5 Field Survey Map









### Figure 08-6 Land Use Map









## Figure 08-7 Cultural and Recreational Map















