- {¶ 1} On April 27, 2021, the above-captioned application was filed pursuant to Ohio Adm.Code 4901:1-40-04(D) for certification as an eligible Ohio renewable energy resource generating facility as defined in R.C. 4928.01.

- {¶ 6} Additionally, Ohio Adm.Code 4901-1-08(A) requires that corporations or other business entities be represented by an attorney-at-law at proceedings in front of the Commission. Therefore, any corporation or other business entity in this proceeding will be
