- {¶ 1} On March 30, 2021, Bluegrass Ridge Wind filed the above-captioned application pursuant to Ohio Adm.Code 4901:1-40-04(D) for the certification of the facility as an eligible Ohio renewable energy resource generating facility as defined in R.C. 4928.01.
- {¶ 2} By Entry filed on April 5, 2021, the attorney examiner suspended the automated approval process pursuant to Ohio Adm.Code 4901:1-40-04(D), which provides that upon good cause shown, the Commission may suspend the certification of an application to allow the Commission and its Staff to further review the application.
- {¶ 3} On April 26, 2021, Carbon Solutions Group, LLC filed a motion for leave to intervene out of time, motion to consolidate, and a procedural schedule in the case.
- {¶ 4} At this time, the attorney examiner schedules a telephonic prehearing conference on July 19, 2021, at 10:00 a.m. ET. At the designated time of the conference, the parties shall dial 614-721-2972 and enter access code 229 333 295# to join the conference. The attorney examiner will conduct a discussion of procedural issues including possible stipulations of fact and potential hearing dates.
- {¶ 5} Any party wishing to intervene in this matter should file a motion to intervene by July 12, 2021.
- {¶ 6} Additionally, Ohio Adm.Code 4901-1-08(A) requires corporations to be represented by an attorney-at-law at proceedings in front of the Commission. Therefore, any corporation in this proceeding will be required to be represented by legal counsel for all further proceedings in this case, including the prehearing conference.
