## EXHIBIT C DESCRIPTION OF FILING

Applicant proposes to modify its Intrastate Access Service Tariff to comply with the Federal Communications Commission's ("FCC") Report and Order, WC Docket No. 18-156, FCC 20-143, *In re 8YY Access Charge Reform* (Released October 9, 2020) and this Commission's Entry of June 7, 2021 in Case No. 10-2387-TP-COI.

The FCC directed local exchange carriers ("LECs") to cap all originating toll-free end office, tandem switching, transport and toll free database query rates as of the effective date of the Report and Order. As part of a phased down approach to bill and keep over a three year period, all local exchange carriers must create separate rate elements for interstate and intrastate toll free originating end office access service and non-toll free originating end office access service. LECs are required to bring any intrastate originating 8YY end office access rates that exceed the comparable interstate rates into parity with the comparable interstate rates effective July 1, 2021.

LECs are also required to establish separate rate elements for interstate and intrastate non-toll free originating transport service between an end office switch and the tandem switch and remove its rates for intrastate and interstate originating toll free transport services. The FCC adopted a single uniform nationwide Joint Tandem Switched Transport Access rate element for toll free calls with a cap of \$0.001 per minute.

The FCC also required LECs to reduce interstate and intrastate rates for Toll Free Database Query charges to no more than \$0.00428 per query.

This filing modifies the intrastate tariff as required by the FCC Report and Order and this Commission's Entry in Case No. 10-2387-TP-COI, and provides references to Applicant's interstate tariff, NECA Tariff FCC No. 5, thereby accomplishing the required results.
