In the Matter of the Application of Harvey Solar I, LLC for a Certificate of Environmental Compatibility and Public Need to Construct a Solar-Powered Electric Generation Facility in Licking County, Ohio.

Dear Ms. Troupe:

Pursuant to Ohio Administrative Code ("O.A.C.") Rule 4906-3-03(A), Harvey Solar I, LLC ("Applicant" or "Harvey Solar") files this Preapplication Notification Letter with the Ohio Power Siting Board ("Board") regarding its proposed solar-powered electric generation facility.

The proposed facility, the Harvey Solar Project, is a solar-powered electric generation facility located in Bennington and Hartford Townships, Licking County, Ohio. The facility will be sited on approximately 2,865 acres and have a maximum total generating capacity of up to 350 megawatts. The purpose of the facility is to generate on-peak electricity to deliver to the AEP Ohio bulk transmission system within the PJM Interconnection. Construction is anticipated to begin as early as the fourth quarter of 2022, resulting in commercial operations in the fourth quarter of 2023.

On Wednesday, July 14, 2021 from 5 p.m. to 8 p.m., Harvey Solar will host an in-person public information meeting at the Hartford Fairgrounds 4-H Building located at 14028 Fairgrounds Rd, Hartford, OH 43013. The meeting will be an open house format, with posterboards containing information addressing the facility in addition to video and printed resources. While the doors open at 5 p.m., the informal open house format means that attendees can come at any time between 5 p.m. and 8 p.m. and will have the same opportunity to learn about the facility at their own pace. Company representatives will be available to respond to inquiries regarding the facility.

In addition to the in-person public information meeting on July 14, 2021, Harvey Solar will host a public information meeting on Thursday, July 15, 2021, from 6 p.m. to 8 p.m., that will be virtual and will consist of a presentation about the proposed facility and approval process, as well

as a live web question and answer ("Q&A") session on the project. To access the live virtual public information meeting and Q&A session online, on Thursday, July 15, 2021, attendees must register in advance online at the following link: https://attendee.gotowebinar.com/register/6919106143156524302. The registration link will also be accessible at www.harveysolar.com on the home page. To access the webinar online, participants must log in using their unique participant link that will be sent to them upon registration.

To listen in to the July 15, 2021 meeting by phone, attendees can call toll free +1 (415) 655-0060 and use access code 568-098-871. No advance registration is necessary for individuals who access by phone. If participants would like a printed handout of the presentation mailed to them, hard copies can be requested by contacting the Harvey Solar team at (614) 219-9203 or at harvey@openroadrenewables.com at least one week in advance (by July 7).

At this time, the Applicant has not determined whether it will be filing any requests for waiver from the Board's rules regarding the electric generation facility application to be filed with the Board.
