The SWPPP for the proposed Duke Energy AA00 Pipeline Replacement in Delhi Township has been reviewed for compliance with the requirements of the Earthwork Regulations. The Earthwork Permit has been approved. The following items must be addressed prior to the issuance of the permit.

1. Sites disturbing more than 1 acre of ground for construction activities must file a notice of intent (NOI) to the Ohio EPA for Storm Water discharges associated with construction. The 2018 Construction General Permit (CGP) requires the approval of the Storm Water Pollution Prevention Plan first be obtained from Hamilton County prior to filing the NOI. **A copy of the approved NPDES Construction NOI must be provided to the District. Instructions to file this notice can be viewed at: <https://ebiz.epa.ohio.gov/login.html>.**
2. A pre-construction meeting is required with a representative of the owner/developer, and general contractor prior to the issuance of the Earthwork Permit and the start of any earthwork. Please contact District Technician [REDACTED] at [REDACTED] [\[REDACTED\]@hamilton-county.org](mailto:[REDACTED]@hamilton-county.org) to schedule the meeting.
3. Earthwork Fees must be paid prior to the issuance of the Earthwork Permit. The earthwork fee for the project is \$1,600.00. The fee can be paid by credit card or by check made payable to:
