S1.1 Intrastate Carrier Access Service

S1.1.A. This Company, hereinafter called the concurring company, assents to, adopts and concurs in the regulations, rates and charges for the provision of intrastate Carrier Access Service as specified in the Windstream Telephone System Access Service Tariff, F.C.C. No. 6, filed with the Federal Communications Commission as such tariff now exists, or as it may be revised, added to or supplemented by superceding sheets or issues; provided however, that the regulations, rates and charges specified in Section 4, End User Access Service, have been excluded from intrastate customers by order of the Public Utilities Commission of Ohio and provided that the rates for Carrier Common Line and Local Switching applicable to the intrastate jurisdiction are those presented below in Sections 3 and 6, respectively.
