Dear Sirs and Mesdames,

I am writing in support of the Pleasant Prairie Solar Energy Center. It is important, as nuclear power plants go off line, as coal fired plants are closed, that Central Ohio have a good supply of clean, renewable energy. The proposed Solar Energy Center will be able to power almost 50,000 homes each year, equivalent to taking 54,000 cars off the road. It will reduce pollution-related health issues, resulting in health care cost savings, fewer cases of breathing illness, fewer missed school days, and lives saved. Both Columbus and Grove City have approved Community Choice Aggregation for 100% renewable energy to be locally supplied.

In addition, the Solar Energy Center will pay \$59 million in lease payments to local landowners, create construction, operations and maintenance jobs, and pay \$4.4 million each year to county and township governments. As a resident of Franklin County and a person deeply concerned about our response to climate change, I urge you to approve the Pleasant Prairie Solar Energy Center.
