- {¶ 1} On June 14, 2021, Ambit Northeast, LLC (Ambit) filed applications to renew its certification as a competitive retail electric service (CRES) provider and a competitive retail natural gas service (CRNGS) supplier in Ohio.
- {¶ 2} In accordance with R.C. 4929.20 and Ohio Adm.Code 4901:1-27-10, as well as R.C. 4928.08 and Ohio Adm.Code 4901:1-24-10, Ambit's applications are subject to a 30-day automatic approval process. Ohio Adm.Code 4901:1-27-10 and 4901:1-24-10 further provide that, upon good cause shown, the Commission or an attorney examiner may suspend consideration of a certificate application. If an application for certification is suspended, the Commission shall act to approve or deny the application within 90 days of the suspension.
- $\P$  3 Staff has requested that the automatic approval process be suspended to allow for additional time to review the applications.
- $\{\P 4\}$  The attorney examiner finds that good cause exists to suspend the 30-day automatic approval process with respect to Ambit's renewal applications for certification, in order that the Commission and Staff may review the matter further.
