## REPORT UPDATE OF THE JUST ENERGY COMPANIES

On March 24, 2021, the Public Utilities Commission of Ohio (the "Commission") issued an Entry in the captioned proceedings (the "Entry") and ordered Just Energy Solutions Inc., Hudson Energy Services LLC, and Interactive Energy Group LLC (collectively, the "Just Energy Companies") to file a report, which was timely filed on April 9, 2021 ("April 9 Report"), answering certain questions regarding the Just Energy Companies' operations in light of their filing for protection under the *Companies' Creditors Arrangement Act* ("CCAA") in Canada and under Chapter 15 of the U.S. Bankruptcy Code ("Chapter 15") in the United States. The Entry further requires the Just Energy Companies to update the April 9 Report every 90 days. This is the Just Energy Companies' first update to the April 9 Report.

The Just Energy Companies continue to serve their customers and have no intention to cease, downsize, or otherwise shut down their operations. As anticipated, the CCAA process has allowed the Just Energy Companies and their affiliates to continue as going concerns, serve their valued customers, including customers in Ohio, and maintain employment for their employees. Further, as the Just Energy Companies committed in the April 9 Report, the CCAA and Chapter 15 filings have had no impact on customer bills.

The CCAA and Chapter 15 proceedings involving the Just Energy Companies remain ongoing, and the Just Energy Companies do not currently have an estimate of when these proceedings will conclude. The Ontario Superior Court of Justice recently extended the stay period under the CCAA proceeding to September 30, 2021. This extended stay period will allow the Just Energy Companies to focus on growing the business and to continue engaging with key stakeholders, with a view of implementing a value maximizing emergence plan.

In accordance with the Entry, the Just Energy Companies hereby submit the following responses to the questions posed by the Commission, which are unchanged from the Just Energy Companies' responses to these questions in the April 9 Report:

1. Whether the Just Energy Companies plan, and are able, to continue to serve their existing customers for competitive retail electric service ("CRES") and competitive retail natural gas service ("CRNGS") in Ohio.

5. Whether the Just Energy Companies have met their obligations to provide collateral or other financial guarantees or other assurances to the electric and natural gas distribution utilities where the Just Energy Companies continue to operate.

At this time, the Just Energy Companies do not have any additional material changes to report under Ohio Adm. Code 4901:1-24-11(A) or Ohio Adm. Code 4901:1-27-11(A). Should there be any material change in information, the Just Energy Companies will notify the Commission as required by Ohio Adm. Code 4901:1-24-11(A) and Ohio Adm. Code 4901:1-27-11(A).

The Just Energy Companies will continue to update the April 9 Report every 90 days, as required by the Entry.
