On July 2, 2021, Hecate Energy Highland 4, LLC (“Highland 4”) and Hecate Energy Highland 2, LLC (“Highland 2”) (collectively, the “Joint Applicants”) filed a Joint Application to Transfer (“Joint Application”). Through the Joint Application, the Joint Applicants seek approval for Highland 4 to transfer the 35 MW phase of the 100 MW Certificate (“Certificate”) granted in this case by the Ohio Power Siting Board (“OPSB”) on March 18, 2021 and modified upon rehearing on June 24, 2021, from Highland 4 to Highland 2.
