Dear Ms. Troupe:

Pursuant to Ohio Adm.Code 4906-6-03(A), Long Ridge Energy Generation LLC (“Long Ridge”) files this pre-application notification letter. Long Ridge will soon be filing a letter of notification application amending the construction certificate previously issued in Case No. 17-1091-EL-BLN. The application in Case No. 17-1091-EL-BLN was automatically approved pursuant to R.C. 4906.03(E) and Ohio Adm.Code 4906-6-10(A) on July 28, 2017.

As explained in the original letter of notification and subsequent filings made in Case No. 17-1091-EL-BLN from November 2, 2018 to February 11, 2020, Long Ridge will construct, own, and operate the Long Ridge Energy Generation project (“the Project”) at the Long Ridge Energy Terminal, an existing industrial facility that was the site of the former Ormet Primary Aluminum Corporation aluminum reduction plant. The Project continues to consist of a 485 megawatt natural gas-fired combined cycle electric generating facility located entirely within Hannibal, Monroe County, Ohio. The only change that will be requested through the letter of notification application in this case is to allow for the use of a hydrogen-natural gas fuel blend. The Project is currently under construction and anticipated to be in service by approximately October 1, 2021.

Pursuant to Ohio Adm.Code 4906-6-04, Long Ridge requests a 28-day expedited review of the application.
