P.U.C.O. No. 2 Tariff for Gas Service

PERCENTAGE OF INCOME PAYMENT PLAN ("PIPP") RIDER

In addition to all other rates and charges applicable to service provided under the General Service rate schedule (Sheet No. 9) or the Transportation Service rate schedule (Sheet No. 10), Customers receiving service pursuant to said rates shall pay an additional amount per Ccf. The PIPP Rider is updated annually, including reconciliation for any over- or under-collections. The PIPP Rider may also include Customer refunds if the Commission or Supreme Court of Ohio determines, as a result of the Commission's biennial audit of the rider, that the Company's PIPP Rider was unlawful or unreasonable or included imprudent amounts. The monthly charge may be revised in accordance with the Commission's Order in Case No. 87-244-GE-UNC. The current recovery of PIPP arrearages is \$(0.0002) per Mcf billed.
