

Notice of Proposed Major Utility Facility

Pleasant Prairie Solar Energy LLC (Pleasant Prairie Solar), a wholly-owned subsidiary of Invenergy, is proposing to construct a solar-powered electric generation facility of up to 250 megawatts located in Franklin County, Ohio, in the townships of Pleasant and Prairie. The facility will be sited on approximately 1,729 acres. The general purpose of the facility is to produce clean, renewable, reliably priced, low-cost electricity to the Ohio bulk power transmission system.

Pleasant Prairie Solar filed its application with the Ohio Power Siting Board (OPSB) for a certificate to construct, operate, and maintain the proposed facility in OPSB Case No. 20-1679-EL-BGN. A copy of the application is available on the OPSB website at <http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=20-1679&x=13&y=13> and Pleasant Prairie's website at <https://pleasantprairiesolar.com/>. The application is currently pending.

On May 11, 2021, the OPSB established the procedural schedule in this case. The first notice of the procedural schedule was published in *The Columbus Dispatch*, a newspaper of general circulation in the project area, on May 26, 2021.

On June 28, 2021, the OPSB directed that the local public hearing and the adjudicatory hearing will no longer occur via Webex but will now take place in person.

Consistent with CDC Guidelines and the May 17, 2021 Ohio Department of Health Order, unless otherwise specified by the facility, individuals who are not fully vaccinated should continue to wear a face covering and socially distance. Please contact the legal department at 614-466-6843 to ask any questions or request accommodations related to health protocols.

The public will be given an opportunity to comment on the proposed facility.

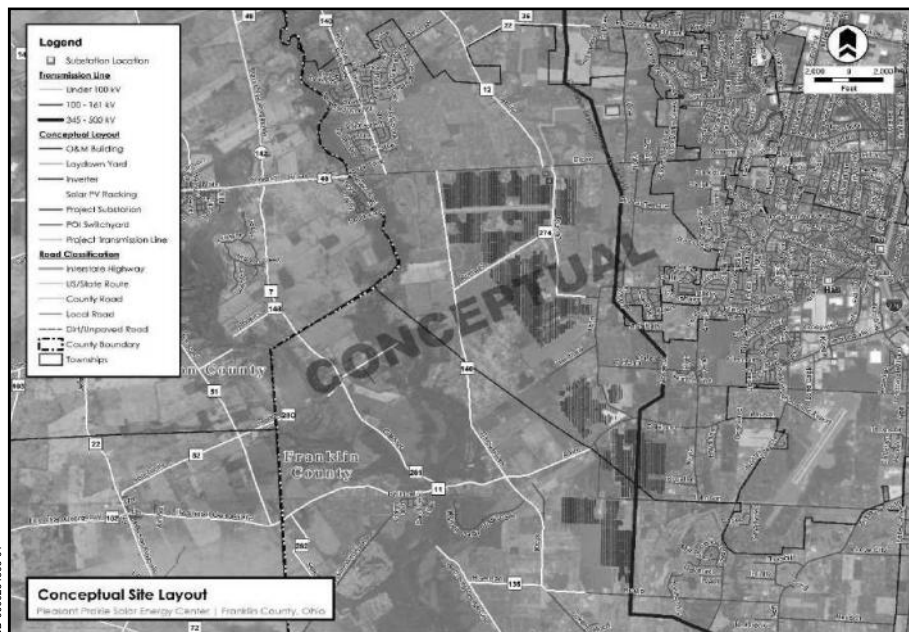
The local public hearing, where the OPSB shall accept written or oral testimony from any person, will no longer occur via Webex but will now take place at Battelle Darby Creek Metro Park Nature Center, 1415 Darby Creek Drive, Galloway, Ohio 43119. The local public hearing will commence, as scheduled, on July 19, 2021, at 6:00 p.m. Individuals are not required to register on-line in order to testify at the local public hearing. Rather, a sign-in sheet will be available at the facility and witnesses will be taken in the order in which they register to testify.

The adjudicatory hearing will no longer occur via Webex but will now take place at the Public Utilities Commission offices in Hearing Room 11-A, 11th Floor, 180 East Broad Street, Columbus, Ohio 43215-3793. The adjudicatory hearing will commence, as scheduled, on August 16, 2021, at 10:00 a.m.
