Now comes Columbia Gas of Ohio, Inc. (“Columbia”) in accordance with the Attorney Examiner’s Entry dated July 17, 2021, submitting this Statement informing the Public Utilities Commission of Ohio (“Commission”) whether the issues have been resolved.

On July 1, 2021, Staff filed its Staff Review and Recommendation recommending approval of Columbia’s CEP Rider rates as filed on February 25, 2021 and as modified by the Blue Ridge Consulting Services Audit Report filed on June 15, 2021. Staff also recommended the adoption of the enumerated recommendations in the Blue Ridge Consulting Services Audit Report. Columbia agrees with Staff’s Conclusions and Recommendations filed in this proceeding.
